1. Purpose of the Policy

The centre is committed to ensuring that the exams management and administration process is run effectively and efficiently and in compliance with the published JCQ regulations and awarding body requirements.

This Exam Policy will ensure that:

- All aspects of the centre's exam process are documented, supporting the exams contingency plan, and other relevant exams-related policies, procedures and plans are signposted to
- The workforce is well informed and supported
- All centre staff involved in the exams process clearly understand their roles and responsibilities
- All exams and assessments are conducted according to JCQ and awarding body regulations, guidance and instructions, thus maintaining the integrity and security of the exam/assessment system at all times
- Exam candidates understand the exams process and what is expected of them

This policy is reviewed annually to ensure ways of working in the centre are accurately reflected and that exams and assessments are conducted to current JCQ (and awarding body) regulations, instructions and guidance.

This policy will be communicated to all relevant centre staff via the staff shared area.

2. Roles and Responsibilities

The Head of Centre is the individual who is accountable to the awarding bodies for ensuring that the centre is always compliant with the published JCQ regulations and awarding body requirements to ensure the security and integrity of the examinations/assessments.

The Examinations Officer is the person appointed by the Head of Centre to act on behalf of, and be the main point of contact for, the centre in matters relating to the general administration of awarding body examinations and assessments.

The Head of Centre may not appoint themselves as the Examinations Officer. A Head of Centre and an Examinations Officer are two distinct and separate roles. (GR, section 2)

2.1 Head of Centre Responsibilities

The Head of Centre is the individual who is accountable to the awarding bodies for ensuring that the centre is always compliant with the published JCQ regulations and awarding body requirements to ensure the security and integrity of the examinations/assessments.

It is the responsibility of the Head of Centre to ensure that all staff comply with the instructions in this policy. Failure to do so may constitute malpractice as defined in the JCQ publication Suspected Malpractice: Policies and Procedures, 1 September 2022 to 31 August 2023: https://www.jcq.org.uk/exams-office/malpractice (ICE Introduction)

Head of Centre

- Understands the contents, refers to and directs relevant centre staff to annually updated JCQ publications including:
 - o General Regulations for Approved Centres (GR)
 - Instructions for Conducting Examinations (ICE)
 - Access Arrangements and Reasonable Adjustments (AA)
 - Suspected Malpractice Policies and Procedures (SM)
 - Instructions for conducting non-examination assessments (NEA) (and the instructions for conducting coursework)
 - A guide to the special consideration process (SC)
- Ensures the centre has appropriate accommodation to support the size of the cohorts being taught including appropriate accommodation for candidates requiring access arrangements and/or practical assessments
- Where/if using a third party to deliver any part of a qualification (including its assessments) at the centre:
 - maintains oversight of, and responsibility for, the delivery of the qualification in accordance with JCQ regulations and awarding body requirements
 - has in place a written agreement with the third party to ensure there is a shared understanding of the arrangement and will manage the risk of failure by the third party to deliver the expected service
 - ensures that a copy of the written agreement is available for inspection if requested by the awarding body
- Ensures that relevant members of staff respond promptly to actions raised by the JCQ Centre Inspection Service, understanding that failure to do so could result in the same penalties as listed in the previous bullet point
- Ensures that the centre promptly reports any incidents to the relevant awarding body/bodies which might compromise any aspect of assessment delivery such as a cyber-attack
- Ensures other relevant centre staff where they may be involved in the receipt and dispatch of confidential exam materials are briefed on the requirements for maintaining the integrity and confidentiality of the exam materials
- Ensures members of centre staff do not forward emails and letters from awarding body or JCQ personnel without prior consent to third parties or upload such correspondence onto social media sites and applications
- Ensures members of centre staff do not advise parents/candidates to contact awarding bodies/JCQ directly nor provide them with addresses/email addresses of awarding body examining/assessment personnel or JCQ personnel

Recruitment, Selection and Training of Staff

- Retains a workforce of an appropriate size and competence, including sufficient managerial and other resource, to undertake the delivery of the qualification as required by an awarding body. This includes taking reasonable steps to ensure occupational competence where this is required for the assessment of specific qualifications
- Provides fully qualified teachers to mark non-examination assessments, and/or fully qualified assessors for the verification of centre-assessed components
- Enables the relevant Senior Leader(s), the Examinations Officer (EO) and the ALS Lead/SENDCo to receive appropriate training and support in order to facilitate the effective delivery of examinations and assessments within the centre, and ensure compliance with the published JCQ regulations
- Appoints an ALS Lead/SENDCo who will determine appropriate arrangements for candidates with learning difficulties and disabilities
- Ensures that the ALS Lead/SENCo has sufficient time to both manage the
 access arrangements process within the centre and familiarise him/herself with
 the JCQ publication Access Arrangements and Reasonable Adjustments
- Ensures that the Examinations Officer is line managed and actively supported by a member of the Senior Leadership team who has a good working knowledge of the examination system

Internal Governance Arrangements

 Has in place a written escalation process should the Head of Centre, or a member of the Senior Leadership team with oversight of examination administration, be absent

Escalation Process

Appendix 1 – Escalation Policy

Refer to GR (section 5.3 Internal governance arrangements)

- Has in place a member of the Senior Leadership team who will provide support and guidance to the Examinations Officer and ensure that the integrity and security of examinations and assessments is maintained throughout an examination series
- Ensures centre staff undertake key tasks within the exams process and meet internal deadlines set by the EO
- Makes sure that a teacher, a tutor or a senior member of centre staff who teaches the subject being examined, is not an Invigilator during the examination

Delivery of Qualifications

• Delivers qualifications, as required by the awarding body, in accordance with relevant equality legislation. This includes but is not limited to ensuring that

- qualifications are made available to all candidates capable of undertaking them and seeking reasonable adjustments for disabled candidates
- Enables candidates to receive sufficient and up to date laboratory experience, or relevant training where required by the subject concerned

Public Liability

 Complies with local health and safety rules which are in place and that the centre is adequately covered for public liability claims

Security of Assessment Materials

- Takes all reasonable steps to maintain the integrity of the examinations/assessments, including the security of all assessment materials, by ensuring:
 - The location of the centre's secure storage facility in a secure room solely assigned to examinations for the purpose of administering secure examination materials
 - o The secure room only contains exam-related material
 - There are between two and six keyholders only, each of whom must fully understand their responsibilities as a key holder to the secure storage facility
 - Access to the secure room and secure storage facility is restricted to the authorised two to six keyholders and staff named and approved by the Head of Centre are accompanied by a keyholder at all times
 - Appropriate arrangements are in place to ensure that confidential materials are only handed over to authorised members of centre staff
 - The relevant awarding body is immediately informed if the security of question papers or confidential supporting instructions is put at risk
 - That when it is permitted to remove question papers from secure storage, and to avoid potential breaches of security, arrangements are in place to carefully check and record that the correct question paper packets are opened
 - (If it is ever subsequently identified following this check that the wrong question paper packet has been opened, it will be resealed and the incident reported to the relevant awarding body's Malpractice Investigation Team immediately)
- Makes arrangements to receive, check and store question papers and examination material safely and securely at all times and for as long as required in accordance with the current JCQ publication *Instructions for* conducting examinations
- Makes arrangements to receive and issue material received from the awarding bodies to staff and candidates, and notify them of any advice and instructions relevant to the examinations and assessments

 Allows candidates access to relevant pre-release materials on, or as soon as possible after, the date specified by the awarding bodies

Malpractice

- Through taking an ethical approach and working proactively to avoid malpractice among students and staff takes all reasonable steps to prevent the occurrence of any malpractice/maladministration before, during and after assessments have taken place
- Ensures any person involved in administering, teaching or completing examinations/assessments is advised that where malpractice is suspected, or alleged, personal data about them will be provided to the awarding body (or bodies) whose examinations/assessments are involved. Personal data about them may also be shared with other awarding bodies, the qualifications regulator or professional bodies in accordance with the JCQ publication Suspected Malpractice – Policies and Procedures
- Ensures irregularities are investigated and informs the awarding bodies immediately of any alleged, suspected or actual incidents of malpractice or maladministration, involving a candidate or a member of staff, by completing the appropriate documentation
- As required by an awarding body, ensures evidence of any instances of alleged or suspected malpractice (which includes maladministration) is gathered in accordance with the JCQ publication Suspected Malpractice -Policies and Procedures and provides such information and advice as the awarding body may reasonably require

Policies/procedures

 Ensures risks to the exam process are assessed and appropriate risk management processes/contingency plans are in place (that allow the enior Leadership team to act immediately in the event of an emergency or staff absence)

Legislation on sharing information

Under the principles of the General Data Protection Regulations 2018 and the Data Protection Act 2018, children and young adults can assume control over their personal information and restrict access to it from the age of 13. This suggests that candidate consent should be sought to share results or other exams-related information with a third party.

There is no specific JCQ regulation that refers to a 'policy' requirement in this respect though it might be good practice to bring all aspects of the process together in one place thereby confirming the centre complies with <u>GR</u> (section 5.4) **Access arrangements and reasonable adjustments**

Conflicts of Interest

- Ensures the relevant awarding bodies are informed before the published deadline for entries for each examination series of any potential conflict of interest where:
 - o a member of centre staff is taking a qualification at the centre which includes internally assessed components/units (noting that being entered by the centre must be as a last resort where unable to find an alternative centre)
 - a candidate is being taught and prepared for a qualification which includes internally assessed components/units by a member of centre staff with a close relationship to the candidate
- Maintains clear records that confirm the measures taken/protocols in place to mitigate any potential risk to the integrity of the qualifications affected by the above, and where:
 - a member of exams office staff has a close relationship to a candidate being entered for exams and assessments at the centre or at another centre
 - a member of centre staff is taking a qualification at the centre which does not include internally assessed components/units (noting that being entered by the centre must be as a last resort where unable to find an alternative centre)
 - o a member of centre staff is taking a qualification at another centre

Conflicts of Interest Policy (Exams) Appendix 10 - Conflict of Interest Policy

There is no specific JCQ regulation that refers to a 'policy' requirement though this would confirm the centre is complying with the declaration and recording requirements outlined in <u>GR</u> (section 5.3) **Conflicts of interest**

National Centre Number Register

- Provides contact details and an address to which all correspondence in connection with the administration of examinations and assessments can be directed which must be the registered address of the centre
- Ensures the National Centre Number Register annual update is responded to by the end of October
- Takes responsibility for confirming, on an annual basis, that they are both aware of and adhering to the latest version of the JCQ's regulations. This confirmation is managed as part of the National Centre Number Register (NCNR) annual update
- Understands that this responsibility cannot be delegated to a member of the senior leadership team or the examinations officer, and acknowledges that failure to respond to the NCNR annual update, and/or the head of centre's declaration, will result in:
 - o the centre status being suspended
 - the centre not being able to submit examination entries

 the centre not receiving or being able to access question papers and ultimately, awarding bodies could withdraw their approval of the centre

Centre Inspections

- Co-operates with the JCQ Centre Inspection Service, an awarding body or a regulatory authority when subject to an inspection, an investigation or an unannounced visit, and takes all reasonable steps to comply with all requests for information or documentation made by an awarding body or regulatory authority as soon as is practical
- Allows all venues used for examinations and assessments, paperwork and secure storage facilities to be open to inspection
- Understands the JCQ Centre Inspector will identify him/herself with a photo ID card and must be accompanied throughout his/her tour of the premises, including inspection of the centre's secure storage facility

Exams Officer

- Understands the contents of annually updated JCQ publications including:
 - General Regulations for Approved Centres
 - Instructions for conducting examinations
 - o Suspected Malpractice Policies and Procedures
 - Post-Results Services (PRS)
 - o A guide to the special consideration process
- Completes/submits the National Centre Number Register annual update (administered on behalf of the JCQ member awarding bodies by OCR https://ocr.org.uk/administration/ncn-annual-update/) by the end of October each year
 - Confirms the details or informs the awarding bodies of any changes to the centre's contact details through the National Centre Number Register
 - Informs the National Centre Number Register Team immediately (e-mail address – ncn@ocr.org.uk) if any changes occur after the National Centre Number Register annual update has taken place
 - (Where it may be applicable) Informs the National Centre Number Register Team no later than 6 weeks prior to moving to a new address or a re-location of the secure storage facility
 - Informs the National Centre Number Register Team immediately of any other changes in circumstances that could affect the centre's status
- Is familiar with the contents of annually updated information from awarding bodies on administrative procedures, key tasks, key dates and deadlines
- Ensures key tasks are undertaken and key dates and deadlines met
- Recruits, trains and deploys a team of internal/external invigilators; appoints lead invigilators, as required and keeps a record of the content of training provided to invigilators for the required period
- Works with the ALS lead/SENCo to ensure invigilators supervising access arrangement candidates and those acting as a facilitator supporting access

- arrangement candidates fully understand the respective role and what is and what is not permissible in the exam room
- Supports the head of centre in ensuring that awarding bodies are informed (where required) of any conflict of interest declared by members of centre staff and in maintaining records that confirm the measures taken/protocols in place to mitigate any potential risk to the integrity of the qualifications affected before the published deadline for entries for each examination series
- Briefs other relevant centre staff where they may be involved in the receipt and dispatch of confidential exam materials on the requirements for maintaining the integrity and confidentiality of the exam materials

Senior Leaders

- Are familiar with the contents, refer to and direct relevant centre staff to annually updated JCQ publications including:
 - o General Regulations for Approved Centres
 - o <u>Instructions for conducting examinations</u>
 - o Access Arrangements and Reasonable Adjustments
 - o <u>Suspected Malpractice Policies and Procedures</u>
 - <u>Instructions for conducting non-examination assessments (and the instructions for conducting coursework)</u>
 - o A guide to the special consideration process
- Ensure teaching staff undertake key tasks, as detailed in this policy, within the exams process (exam cycle) and meet internal deadlines set by the EO and ALS lead/SENCo
- Ensure teaching staff keep themselves updated with awarding body subject and teacher-specific information to confirm effective delivery of qualifications
- Ensure teaching staff attend relevant awarding body training and update events

Additional Learning Support (ALS) lead/Special educational needs co-ordinator (SENCo)

- Understands the contents, refers to and directs relevant centre staff to annually updated JCQ publications including:
 - o Access Arrangements and Reasonable Adjustments
- Leads on the access arrangements and reasonable adjustments process (referred to in this policy as 'access arrangements')
- If not the qualified access arrangements assessor, works with the person appointed, on all matters relating to assessing candidates and ensures the correct procedures are followed
- Presents when requested by a JCQ Centre Inspector, evidence of the assessor's qualification

Teaching staff

- Undertake key tasks, as detailed in this policy, within the exams process and meet internal deadlines set by the EO and ALS lead/SENCo
- Keep updated with awarding body subject and teacher-specific information to confirm effective delivery of qualifications
- Attend relevant awarding body training and update events

Invigilators

- Attend/undertake training (on the current regulations), annual update, briefing and review sessions as required
- Provide information as requested on their availability to invigilate
- Sign a confidentiality and security agreement and confirm whether they
 have any current maladministration/malpractice sanctions applied to them

Reception Staff

 Support the EO in the receipt and dispatch of confidential exam materials and follow the requirements for maintaining the integrity and confidentiality of the exam materials

Site Staff

• Support the EO in relevant matters relating to exam rooms and resources

Candidates

Where applicable in this policy, the term 'candidates' refers to candidates and/or their parents/carers.

3. The Exam Cycle

The exams management and administration process that needs to be undertaken for each **exam series** is often referred to as the **exam cycle** and relevant tasks required within this grouped into the following stages:

- Plannina
- Entries
- Pre-exams
- Exam time
- Results and post-results

This policy identifies roles and responsibilities of centre staff within this cycle.

3.1 Planning: Roles and Responsibilities

Information Sharing:

Head of Centre

• Directs relevant centre staff to annually updated JCQ publications including GR, ICE, AA, SM, NEA (and the Instructions for conducting coursework) and SC

Examinations Officer

- Signposts relevant centre staff to JCQ publications and awarding body documentation relating to the exams process that have been updated
- Signposts relevant centre staff to JCQ information that should be provided to candidates
- As the centre administrator, approves relevant access rights for centre staff to access awarding body secure extranet sites

Information Gathering:

Examinations Officer

- Undertakes an annual information gathering exercise in preparation for each new academic year to ensure data about all qualifications being delivered is up to date and correct
- Collates all information gathered into one central point of reference
- Researches awarding body guidance to identify administrative processes, key tasks, key dates and deadlines for all relevant qualifications
- Produces an Annual Exams Plan of key tasks and key dates to ensure all external deadlines can be effectively met; informs key centre staff of internal deadlines
- Collects information on internal exams to enable preparation for and conduct of (insert the titles these internal exams are referred to in the centre)

Senior Leaders

- Respond (or ensure teaching staff respond) to requests from the EO on information gathering
- Meet the internal deadline for the return of information
- Inform the EO of any changes to information in a timely manner minimising the risk of late or other penalty fees being incurred by an awarding body
- Note the internal deadlines in the annual exams plan and directs teaching staff to meet these

Access Arrangements:

Head of Centre

- Ensures there is appropriate accommodation for candidates requiring access arrangements in the centre for all examinations and assessments
- Ensures a written process is in place to not only check the qualification(s) of the appointed assessor(s) but that the correct procedures are followed as per

Chapter 7 of the JCQ publication <u>Access Arrangements and Reasonable</u> Adjustments

• Ensures the ALS Lead/SENDCo is fully supported in effectively implementing access arrangements and reasonable adjustments once approved

ALS Lead/SENDCo

- Assesses candidates (or works with the appropriately qualified assessor as appointed by the Head of Centre) to identify access arrangements/reasonable adjustments requirements
- Gathers evidence to support the need for access arrangements for a candidate
- Liaises with teaching staff to gather evidence of normal way of working of an affected candidate
- Determines candidate eligibility for arrangements or adjustments that are centre-delegated
- Gathers signed Personal Data Consent, Privacy Notice (AAO) and Data Protection confirmation forms from candidates where required
- Applies for approval through Access Arrangements Online (AAO) via the Centre Admin Portal (CAP), where required or through the awarding body where qualifications sit outside the scope of AAO
- Keeps a file for each candidate for JCQ inspection purposes containing all the required documentation (if documentation is stored electronically, an e-folder must be created for each individual candidate. The candidate's e-folder must hold each of the required documents for inspection)
- Employs good practice in relation to the Equality Act 2010
- Liaises with the EO regarding exam time arrangements for access arrangement candidates
- Ensures staff appointed to facilitate access arrangements for candidates are appropriately trained and understand the rules of the particular arrangement(s) and keeps a record of the content of training provided to facilitators for the required period
- Works with the EO to ensure Invigilators and those acting as a facilitator fully understand the respective role and what is and what is not permissible in the exam room
- Liaises with the relevant member of the Senior Leadership team on the centre's policy on the use of word processors in examinations

Separate invigilation within the centre (sitting the examination outside of the main examination hall/room e.g. a room for a smaller group of candidates)

Senior Leaders, Teaching staff

- Support the ALS Lead/SENDCo in determining and implementing appropriate access arrangements/reasonable adjustments
- Provide a statement for inspection purposes which details the criteria the centre uses to award and allocate word processors for examinations

Internal Assessment and Endorsements:

Head of Centre

Controlled assessments, coursework and non-examination assessments

- Ensures arrangements are in place to co-ordinate and standardise all marking
 of centre- assessed components and ensures that candidates' centreassessed work is produced, authenticated and marked, or assessed and
 quality assured in accordance with the awarding bodies' instructions
 (including where relevant, private candidates)
- Ensures that teaching staff, in accordance with awarding bodies' instructions, return all subject-specific forms by the required date
- Provides fully qualified teachers to mark non-examination assessments, and/or fully qualified assessors for the verification of centre-assessed components
- Ensures an **internal appeals procedure** relating to internal assessment decisions is in place for a candidate to appeal against and request a review of the centre's marking (see Roles and responsibilities overview)
- Ensures a **non-examination assessment policy** is in place for GCE and GCSE qualifications which include components of non-examination assessment (For CCEA GCSE centres this would be a controlled assessment policy)

Non-examination Assessment Policy

Senior Leaders

 Ensure teaching staff have the necessary and appropriate knowledge, understanding, skills, and training to set tasks, conduct task taking, and to

- assess, mark and authenticate candidates' work (including where relevant, private candidates)
- Ensure appropriate internal moderation, standardisation and verification processes are in place
- Ensure teaching staff delivering AQA Applied General qualifications, OCR
 Cambridge Nationals, Entry Level Certificate or Project qualifications (and
 CCEA GCE unitised AS and A-level qualifications) follow JCQ <u>Instructions for</u>
 conducting coursework and the specification provided by the awarding body
- Ensure teaching staff delivering reformed GCE & GCSE specifications (which
 include components of non-examination assessment) follow JCQ <u>Instructions</u>
 <u>for conducting non-examination assessments</u> and the specification provided
 by the awarding body
- For other qualifications, ensure teaching staff follow appropriate instructions issued by the awarding body
- Ensure teaching staff inform candidates of their centre assessed marks as a candidate may request a review of the centre's marking before marks are submitted to the awarding body

Teaching Staff

- Ensure appropriate instructions for conducting internal assessment are followed
- Ensure candidates are aware of JCQ and awarding body information for candidates on producing work that is internally assessed (coursework, non-examination assessments, social media) prior to assessments taking place
- Ensure candidates are informed of their centre assessed marks as a candidate may request a review of the centre's marking before marks are submitted to the awarding body

Examinations Officer

- Identifies relevant key dates and administrative processes that need to be followed in relation to internal assessment
- Signposts teaching staff to relevant JCQ <u>Information for candidates</u> <u>documents</u> that are annually updated

Invigilation:

Head of Centre

- Ensures relevant support is provided to the EO in recruiting, training and deploying a team of Invigilators
- Ensures, if contracting supply staff to act as Invigilators, that such persons are competent and fully trained, understanding what is and what is not permissible (and not taking on its own an assurance from a recruitment agency, that this is the case)

 Determines if additional Invigilators will be deployed in timed Art exams in addition to the subject teacher to ensure the supervision of candidates is maintained at all times

Examinations Officer

- Recruits additional Invigilators where required to effectively cover all exam periods/series throughout the academic year
- Collects information on new recruits to identify if they have invigilated previously and if any current maladministration/malpractice sanctions are applied to them
- Provides training for new Invigilators on the instructions for conducting exams and an annual update for the existing invigilation team so that they are aware of any changes in a new academic year before they are allocated to invigilate an exam
- Ensures Invigilators supervising access arrangement candidates understand their role (and the role of a facilitator who may be supporting a candidate) and the rules and regulations of the access arrangement(s)
- Ensures Invigilators are briefed on the access arrangement candidates in their exam room and made aware of the access arrangement(s) awarded (ensuring these candidates are identified on the seating plan) and confirms Invigilators understand what is and what is not permissible
- Collects evaluation of training to inform future events

Entries: Roles and Responsibilities

Estimated Entries

Examinations Officer

 Requests estimated or early entry information, where this may be required by awarding bodies, from Heads of Department/Curriculum Leaders in a timely manner to ensure awarding body external deadlines for submission can be met

Estimated Entries Collection and Submission Procedure:

• Estimated entries information is requested from teachers in September. The template used includes Subject, QN, number of candidates and the units to be entered if applicable

Senior Leaders

- Provide entry information requested by the EO to the internal deadline
- Inform the EO immediately of any subsequent changes to entry information

Final Entries

Examinations Officer

- Requests final entry information from Heads of Department/Curriculum Leaders in a timely manner to ensure awarding body external deadlines for submission can be met
- Informs Heads of Department/Curriculum Leaders of subsequent deadlines for making changes to final entry information without charge
- Confirms with Heads of Department/Curriculum Leaders final entry information that has been submitted to awarding bodies
- Ensures as far as possible that entry processes minimise the risk of entries or registrations being missed reducing the potential for late or other penalty fees being charged by awarding bodies
- Observes each awarding body's terms and conditions for the entry and withdrawal of candidates for their examinations and assessments, and observes any regulatory requirements for the qualification

Final Entries: Collection and Submission Procedure Examinations Officer

For non-tiered subjects the Examinations Officer will make an entry for all students enrolled on the course. An entry list is then sent to the Heads of Department (HoD)/Curriculum Leaders (CL) to be checked and signed off once all entries are correct. These are all held as an e-file by the Examinations Officer.

Where a subject is tiered, the Exams Officer will send a template to the Head of Department that is split by the subject and tier to be entered. The HOD will enter student names on the sheet and return it to the Exams Officer. The Exams Officer will then enter the entries on the system and send the entries back to the HOD for a final check. Entries will not be submitted until all sheets are returned signed and dated.

Senior Leaders

- Provide information requested by the EO to the internal deadline
- Inform the EO immediately, or at the very least prior to the deadlines, of any subsequent changes to final entry information, which includes:
 - Changes to candidate personal details
 - Amendments to existing entries
 - Withdrawals of existing entries
- Check final entry submission information provided by the EO and confirms information is correct

Entry Fees

The Exams Officer keeps a spreadsheet to track estimated cost. The spreadsheet details the number of entries for a subject with numbers taken from the MIS and the cost as published by the relevant examination board.

Late Entries

Examinations Officer

- Has clear entry procedures in place to minimise the risk of late entries
- Charges any late or other penalty fees to departmental budgets

Senior Leaders

- Minimise the risk of late entries by
 - Following procedures identified by the EO in relation to making final entries on time
 - Meeting internal deadlines identified by the EO for making final entries

Private Candidates

Private Candidates are accepted in exceptional circumstances. Candidate information is collected using the Private Candidates form from The Exams Office website. Charges include a £50 administration fee, the actual cost of the exam entry as published by the examinations board plus an invigilator fee if applicable.

Candidate Statements of Entry

Examinations Officer

Provides candidates with statements of entry for checking and signing

Teaching Staff

 Ensure candidates check statements of entry and return any relevant confirmation required to the EO

Candidates

Confirm entry information is correct or notify the EO of any discrepancies

Pre-exams: Roles and Responsibilities

Access Arrangements and Reasonable Adjustments

- Ensures appropriate arrangements, adjustments and adaptations are in place
 to facilitate access to exams/assessments for candidates where they are
 disabled within the meaning of the Equality Act (unless a temporary
 emergency arrangement is required at the time of an exam)
- Ensures a candidate is involved in any decisions about arrangements, adjustments and /or adaptations that may be put in place for him/her
- Ensures exam information (JCQ information for candidates documents, individual exam timetable etc.) is adapted where this may be required for a disabled candidate to access it
- Allocates appropriately trained centre staff to facilitate access arrangements for candidates in exams and assessments (ensuring that the facilitator appointed meets JCQ requirements and fully understands the rule of the access arrangement)
- Where relevant, ensures the necessary and appropriate steps are undertaken
 to gather an appropriate picture of need and demonstrate normal way of

 - When and how results will be issued and the staff that will be available

Access to Scripts, Reviews of Results and Appeals Procedures

Results

Candidates will receive individual results slips on results days either in person at the centre or by post to their home addresses (candidates to provide postage).

The Head of Centre and Examinations Officer arrange for the school to be open on results days.

The provision of staff on results days is the responsibility of the Head of Centre.

EARs

The centre is obliged to publish a separate procedure on this subject, which is included in this document and further guidance can be obtained from the Examinations Officer.

EARs may be requested by centre staff or candidates / parents or carers if there are reasonable grounds for believing there has been an error in marking.

If a result is queried, the Examinations Officer, teaching staff and Head of Centre will investigate the feasibility of asking for a re-mark at the centre's expense.

When the centre does not uphold an EAR, a candidate may apply to have an enquiry carried out. If a candidate requires this against the advice of subject staff, they will be charged. Payment will be required before the enquiry is submitted. If successful, the payment will be refunded.

ATS

After the release of results, candidates may ask subject staff to request the return of papers within three days' scrutiny of the results.

Centre staff may also request scripts for investigation or for teaching purposes. For the latter, the consent of candidates must be obtained.

Examinations Officer

- Submits estimated grade information to awarding bodies to meet the external deadline (where this may still be required by the awarding body)
- Keeps a record to track what has been sent

 Ensures procedures are in place for candidates to appeal internal assessment decisions and make requests for reviews of marking

- Ensures that information is readily available for inspection at the venue where the candidate is taking the exam(s)

Seating and Identifying Candidates in Exam Rooms

Examinations Officer

- Ensures a procedure is in place to verify the identity of all candidates
- Ensures Invigilators are aware of the procedure
- Provides seating plans for exam rooms according to JCQ and awarding body requirements (and ensures candidates with access arrangements are identified on the seating plan and invigilators are informed of those candidates with access arrangements and made aware of the access arrangement(s) awarded)

Candidate Identification Procedure

- Internal Candidates will be identified by way of identity cards on the desk for each exam that also include a picture of the candidate. A member of the Senior Leadership Team will be present outside the examination room at the start of each exam
- Private Candidates are required to send in identification with their application
 for entries which will be held on file by the Examinations Officer. They are then
 required to bring their passport or another form of identity prior to their first
 exam. This will be copied and certified as a true copy of the original and

Candidates wearing religious clothing that covers their face will be taken to a

Invigilators

- Follow the procedure for verifying candidate identity provided by the EO

Security of Exam Materials

Examinations Officer

- Confirms appropriate arrangements are in place to ensure that confidential materials are only handed over to those authorised by the Head of Centre
- Ensures access to the secure room is restricted and staff named and approved by the Head of Centre are accompanied by a keyholder at all times. There must be between two and six keyholders only, each of whom must fully understand their responsibilities as a key holder to the secure storage facility
- Has a process in place to demonstrate the receipt, secure movement and secure storage of confidential exam materials within the centre
- Ensures a log is kept at the initial point of delivery recording confidential
 materials received and signed for by authorised staff within the centre and
 that appropriate arrangements are in place for confidential materials to be
 immediately transferred to the secure storage facility until they can be
 removed from the dispatch packaging and checked in the secure room
 before being returned to the secure storage facility in timetable order
- Ensures the secure storage facility contains only current and live confidential material (ensuring that past examination question papers, internal tests and mock examinations are not kept in the centre's secure storage facility)
- Ensures that examination stationery, e.g. answer booklets and formula booklets are stored in the secure room (attempting to store this material in the secure storage facility, when sufficient space allows)
- Ensures the integrity and security of any electronic question paper is
 maintained during the downloading, printing and collating process (ensuring
 printing is carried out in an area that can be controlled to prevent
 unauthorised personnel accessing live assessment materials and ensuring only
 authorised members of centre staff have access to electronic question
 papers)

Reception Staff

 Follow the process to log confidential materials delivered to/received by the centre to the point materials are issued to authorised staff for transferal to the secure storage facility

Teaching Staff

 Adhere to the process to record the secure movement of confidential materials taken from or returned to secure storage throughout the time the material is confidential

Timetabling and Rooming

Examinations Officer

- Produces a master centre exam timetable for each exam series
- Identifies and resolves candidate exam timetable clashes according to the regulations (only applying overnight supervision arrangements as a last resort, once all other options have been exhausted and according to the centre's policy)
- Identifies exam rooms and specialist equipment requirements
- Allocates Invigilators to exam rooms (or where supervising candidates due to an exam timetable clash) according to required ratios

- Ensures question papers will only be taken to an alternative site where the published criteria for an alternative site arrangement has been met
- Will inform the JCQ Centre Inspection Service to timescale by submitting a
 JCQ Alternative Site arrangement notification using CAP (or through the
 awarding body where a qualification may sit outside the scope of CAP) of any

alternative sites that will be used to conduct timetabled examination components of the qualifications listed in the JCQ regulations

Transferred Candidate Arrangements

Examinations Officer

- Liaises with the host or entering centre, as required
- Processes requests for Transferred Candidate arrangements using CAP to the awarding body deadline (or through the awarding body where a qualification may sit outside the scope of CAP)
- Where relevant (for an internal candidate) informs the candidate of the arrangements that have been made for their transferred candidate arrangement

Internal Exams

Examinations Officer

- Prepares for the conduct of internal exams under external conditions (where applicable to the centre)
- Provides a centre exam timetable of subjects and rooms

- Provides cover sheets for access arrangement candidates' scripts where required for particular arrangements
- Has a process in place to deal with emergency/temporary access arrangements as they arise at the time of exams

Candidate Absence

Candidate Absence Policy

- A register is completed once all candidates are seated in the exam room to identify any absences
- The Examinations Officer reports all absences to the attendance officer who will attempt to contact the students parents who have not reported their childs absence
- Where possible a member of SLT will go to the students home address in order to get them into school ensuring they have no access to social media
- If a parent or the student cannot be contacted this will result in the absence being unauthorised and the parent may be charged for the entry
- Once candidates are seated and have started the examination, complete
 the attendance register. This will allow for the identification of absent
 candidates who can be contacted as to their whereabouts

Invigilators

- Are informed of the policy/process for dealing with absent candidates through training
- Ensure that confirmed absent candidates are clearly marked as such on the attendance register and seating plan

Candidate Late Arrival

Examinations Officer

- Ensures that candidates who arrive very late for an exam are reported to the awarding body by submitting a report on candidate admitted very late to examination room using CAP to timescale
- Warns candidates that their script may not be accepted by the awarding body

Invigilators

 Are informed of the policy/process for dealing with late/very late arrival candidates through training • Ensure that relevant information is recorded on the exam room incident loa

Candidate Late Arrival Policy

- A student who arrives Very Late will be permitted to enter the exam room to sit
 the exam but will be warned prior to this that their paper may not be
 accepted by the awarding body
- Parents will be contacted and will be required to sign a disclaimer stating that the student did not have access to any form of social media from 9am for a morning exam or 1.30pm for an afternoon exam
- The student and parents will be made aware that a report has to be made to the Awarding Body which may result in the paper not being marked
- For persistent absentees the school may plan for the student to be collected from home prior to each exam. This will only be done in very special circumstances
- A candidate who arrives after the start of the examination may be allowed to enter the examination room and sit the examination. This is entirely at the discretion of the centre
- A candidate who arrives late, and is permitted by the centre to sit the examination, must be allowed the full time for the examination.

Conducting Exams

Head of Centre

 Ensures venues used for conducting exams meet the requirements of JCQ and awarding bodies

Examinations Officer

- Ensures exams are conducted according to JCQ and awarding body instructions
- Uses an exam day checklist to ensure each exam session is fully prepared for, unplanned events can be dealt with and associated follow-up is completed

Dispatch of Exam Scripts

Examinations Officer

- Dispatches scripts as instructed by JCQ and awarding bodies
- Keeps appropriate records to track dispatch

Exam Papers and Materials

Examinations Officer

 Organises exam question papers and associated confidential resources in date order in the secure storage facility

- Attaches erratum notices received to relevant sealed question paper packets
- Collates attendance registers and examiner details in date order
- Regularly checks mail or email inbox for updates from awarding bodies
- In order to avoid potential breaches of security, ensures care is taken to ensure
 the correct question paper packets are opened by ensuring a member of
 centre staff, additional to the person removing the papers from secure
 storage, e.g. an Invigilator, checks the day, date, time, subject,
 unit/component and tier of entry, if appropriate, immediately before a
 question paper packet is opened
- Ensures this additional/second check is recorded
- Where allowed by the awarding body, only releases exam papers and materials to teaching departments for teaching and learning purposes after the published finishing time of the exam, or until any timetable clash candidates have completed the exam

Exam Rooms

Head of Centre

- Ensures that internal tests, mock exams, revision or coaching sessions are not conducted in a room 'designated' as an exam room
- Ensures that when a room is 'designated' as an exam room it is not used for any purpose other than conducting external exams
- Ensures only approved centre staff (who have not taught the subject being examined) are present in exam rooms to perform permitted tasks
- Ensures the centre's policy relating to food and drink that may be allowed in exam rooms is clearly communicated to candidates
- Ensures the centre's policy on candidates leaving the exam room temporarily is clearly communicated to candidates

Food and Drink Policy (Exams)

- Only water in a clear plastic bottle with the label removed will be allowed in the examination room. Any requests for food/drinks other than water must be made in writing to the Examinations Officer prior to the exam.
- Chewing gum is not allowed

Leaving the Examination Room Policy

Candidates will not be allowed to leave the exam room unless they have one of the following:

- A medical needs card in the case of unforeseen circumstance e.g UTI
- A known medical condition
- Sudden onset of illness e.g sickness

The time the student is out of the room will be added back on to the end of the exam. If a candidate leaves due to needing the toilet but does not have any of the above the time will not be compensated unless agreed with the Examinations Officer.

A record must be made on the Exam Room report form of any student that leaves the room during an exam. This information must include the candidate name, candidate number, reason for leaving the room and the times they left and reentered the room.

Candidates must be accompanied all times by a member of the invigilation team.

Examinations Officer

- Ensures exam rooms are set up and conducted as required in the regulations
- Provides Invigilators with appropriate resources to effectively conduct exams
- Briefs Invigilators on exams to be conducted on a session by session basis (including the arrangements in place for any transferred candidates and access arrangement candidates)
- Ensures sole Invigilators have an appropriate means of summoning assistance (if this is a mobile phone, instructs the Invigilator that this must be on silent mode)
- Ensures Invigilators understand they must be vigilant and remain aware of incidents or emerging situations, looking out for malpractice or candidates who may be in distress, recording any incidents or issues on the exam room incident log
- Ensures Invigilators understand how to deal with candidates who may need to leave the exam room temporarily and how this should be recorded on the exam room incident log
- Provides authorised exam materials which candidates are not expected to provide themselves
- Ensures Invigilators and candidates are aware of the emergency evacuation procedure
- Ensures Invigilators are aware of arrangements in place for a candidate with a disability who may need assistance if an exam room is evacuated

Senior Leaders

- Ensure a documented emergency evacuation procedure for exam rooms is in place
- Ensure arrangements are in place for a candidate with a disability who may need assistance if an exam room is evacuated

Emergency Evacuation Policy (Exams)

Document stored in Examinations Officer exam files

Site Staff

- Ensure exam rooms are available and set up as requested by the EO
- Ensure grounds or centre maintenance work does not disturb exam candidates in exam rooms
- Ensure fire alarm testing does not take place during exam sessions

Invigilators

 Conduct exams in every exam room according to JCQ Instructions for conducting examinations and/or awarding body requirements and as instructed by the centre in training/update and briefing sessions

Candidates

- Are required to follow the instructions given to them in exam rooms by authorised centre staff and Invigilators
- Are required to remain in the exam room for the full duration of the exam

Irregularities

Head of Centre

 Ensures (as required by an awarding body) any cases of alleged, suspected or actual incidents of malpractice or maladministration before, during or after examinations/assessments (by centre staff, candidates, Invigilators) are investigated and reported to the awarding body immediately, by completing the appropriate documentation

Managing Behaviour Policy (Exams)

Senior Leaders

- Ensure support is provided for the EO and Invigilators when dealing with disruptive candidates in exam rooms
- Ensure that internal disciplinary procedures relating to candidate behaviour are instigated, when appropriate

Examinations Officer

- Provides an exam room incident log in all exam rooms for recording any incidents or irregularities
- Actions any required follow-up and reports to awarding bodies as soon as practically possible after the exam has taken place

Invigilators

 Record any incidents or irregularities on the exam room incident log (for example, late/very late arrival, candidate or centre staff suspected malpractice, candidate illness or needing to leave the exam room temporarily, disruption or disturbance in the exam room, emergency evacuation)

Special Consideration

Senior Leaders

Provide signed evidence to support eligible applications for special consideration

Examinations Officer

- Processes eligible applications for special consideration to awarding bodies
- Gathers evidence which may need to be provided by other staff in centre or candidates
- Submits requests to awarding bodies to the external deadline

Special Consideration Policy (Exams)

Document stored in Examinations Officer exam files

Special Consideration Policy

Should a candidate be ill before an exam, suffer bereavement or other trauma, be taken ill during the exam itself or otherwise disadvantaged or disturbed during an exam, then it is the candidate's responsibility to alert the centre, the Examinations Officer, or the exam Invigilator, to that effect.

The candidate must support any special consideration claim with appropriate evidence within three days of the exam, for example a letter from the candidate's doctor.

The Examinations Officer will then complete a special consideration application to the relevant awarding body within seven days of the exam.

Candidates

 Provide appropriate evidence to support special consideration applications, where required

Unauthorised Items

Arrangements for Unauthorised Items Taken into the Exam Room

All candidates are asked at the start of the exam to check their pockets for anything they may still have on their person.

If they put their hand up the item is taken by an Invigilator (turned off if applicable) and stored in a box for collection after the exam.

If the exam has started and a candidate is found to have an unauthorised item this is taken and stored by the Examinations Officer. They will be instructed to go straight to their Head of Years office after the exam to collect the item. At this point they will be informed of the procedures that will take place including any potential penalties that could be imposed by the Awarding Body.

Invigilators

Are informed of the arrangements through training

Internal Exams

Examinations Officer

- Briefs Invigilators on conducting internal exams
- Returns candidate scripts to teaching staff for marking

Invigilators

Conduct internal exams as briefed by the EO

Results and Post-results: Roles and Responsibilities

Internal Assessment

Senior Leaders

- Ensures teaching staff keep candidates' work, whether part of the moderation sample or not, secure and for the required period stated by JCQ and awarding bodies
- Ensures work is returned to candidates or disposed of according to the requirements

Managing Results Day(s)

Senior Leaders

- Identify centre staff who will be involved in the main summer results day(s) and their role
- Ensures senior members of staff are accessible to candidates after the
 publication of results so that results may be discussed and decisions made on
 the submission of any requests for post-results services and ensures candidates
 are informed of the periods during which centre staff will be available so that
 they may plan accordingly

Examinations Officer

 Works with Senior Leaders to ensure procedures for managing the main summer results day(s) (a results day programme) are in place

Results Day Programme

Candidates will receive individual results slips on results days either in person at the centre or by email to a personal email address if the Examinations Officer has received prior permission from the Student. Results can be posted to their home address in exceptional circumstances (candidates to provide postage).

Arrangements for the school to be open on results days are made by the Examinations Officer and Head of Centre.

The provision of staff on results days is the responsibility of the Assistant Headteacher in charge of Student Outcomes and Head of Centre.

Site Staff

 Ensure the centre is open and accessible to centre staff and candidates, as required for the collection of results

Accessing Results

Head of Centre

- Ensures results are kept entirely confidential and restricted to key members of staff until the official dates and times of release of results to candidates
- Understands that it is not permitted to withhold provisional results from candidates under any circumstances

Examinations Officer

- Informs candidates in advance of when and how results will be released to them for each exam series
- Accesses results from awarding bodies under restricted release of results, where this is provided by the awarding body
- Resolves any missing or incomplete results with awarding bodies
- Issues statements of results to candidates on issue of results date
- Provides summaries of results for relevant centre staff on issue of results date

Post-results Services

Head of Centre

Ensures an internal appeals procedure is available where candidates disagree
with any centre decision not to support a clerical re-check, a review of
marking, a review of moderation or an appeal

- Ensures that senior members of centre staff are available immediately after the publication of results
- Understands that if the centre has concerns about one of its component/subject cohorts, then requests for reviews of marking should be submitted for all candidates believed to be affected (candidate consent is required as marks and subject grades may be lowered, confirmed or raised)

Examinations Officer

- Provides information to all candidates and staff on the services provided by awarding bodies and the fees charged (see also above Briefing candidates and Access to Scripts, Reviews of Results and Appeals Procedures)
- Publishes internal deadlines for requesting the services to ensure the external deadlines can be effectively met
- Provides a process to record requests for services and to collect candidate informed consent (after the publication of results) and fees where relevant
- Submits requests to awarding bodies to meet the external deadline for the particular service
- Tracks requests to conclusion and informs candidates and relevant centre staff of outcomes
- Updates centre results information, where applicable

Teaching staff

- Meet internal deadlines to request the services and gain relevant candidate informed consent
- Identify the budget to which fees should be charged

Candidates

- Meet internal deadlines to request the services
- Provide informed consent and fees, where relevant

Certificates

Certificates are provided to centres by awarding bodies after results have been confirmed.

Certificate Issue Procedure and Retention Policy

Certificates are presented in person or collected and signed for.

Certificates may be collected on behalf of a candidate by a third party, provided they have been authorised to do so.

Replacement certificates can be obtained on application to the appropriate awarding body. Honley High School does not undertake to request replacement certificates but will advise on procedure if necessary.

The centre retains certificates for 12 months as per JCQ guidelines. After this they are securely disposed of and a record kept of their disposal.

Exams Review: Roles and Responsibilities

Examinations Officer

- Provides SLT with an overview of the exam year, highlighting what went well
 and what could be developed/improved in terms of exams management and
 administrative processes within the stages of the exam cycle
- Collects and evaluates feedback from staff, candidates and Invigilators to inform an exams review

Senior Leaders

 Work with the EO to produce a plan to action any required improvements identified in the review

Retention of records: roles and responsibilities

Examinations Officer

- Keeps records as required by JCQ and awarding bodies for the required period
- Keeps records as required by the centre's records management policy
- Provides an exams archiving policy that identifies information held, retention period and method of disposal

Exams Archiving Policy (Exams)

Document stored in Examinations Officer's exam files
